- 2. AVIATION GROUNDING LIABILITY INSURANCE, for a Combined Single Limit (Bodily Injury/Property Damage) of USD125,000,000 any one occurrence, and in the annual aggregate.

Coverages 1 and 2 are subject to an overall combined single limit (Bodily Injury/Property Damage) of USD250,000,000 any one occurrence and in the annual aggregate.

3. AVIATION WORKING PARTIES LIABILITY / PREMISES AND HANGARKEEPERS LIABILITY INSURANCE, for a Combined Single Limit (Bodily Injury/Property Damage) of USD250,000,000 any one occurrence.

The above mentioned coverage is subject to the War Hi-Jacking and Other Perils Exclusion Clause (Aviation) AVN48B, but coverage in respect of War and Allied Perils is provided in accordance with the Extended Coverage Endorsement (AVN52G) and subject to an overall combined single limit (Bodily Injury / Property Damage) of USD250,000,000 any one occurrence and in the annual aggregate.

Note the above aggregate limit(s) may be reduced or exhausted by claims made in respect of any interest insured under the policy(ies).
